- 5) In 2024 I was asked by our Board Chair to join the Executive Committee of the of the Sea Pines POA Board of Directors and I accepted. I currently serve as Board Secretary.
- 6) Last, but not least, I am currently leading the initiative to transition away from loud/polluting gas-powered handheld/backpack landscape equipment to quieter/clean battery-powered equipment to improve the quality of life in Sea Pines and island-wide. I look forward to seeing this through to fruition.
